**SUBJECT: Amending the boundaries of the Woodcrest Municipal Advisory Council**

**RECOMMENDED MOTION:** That the Board joins me in adopting Resolution No. 2010-194 which will amend the boundaries of the Woodcrest Municipal Advisory Council to include areas to the south and exclude areas to the west and areas recently annexed by the City of Riverside as described by attached Exhibit A.

**BACKGROUND:** On September 7, 1999 the Board of Supervisors adopted Resolution No. 99-194 which established the Woodcrest Municipal Advisory Council. However, recent annexations of portions of Woodcrest by the city of Riverside coupled with improvements of the north / south transportation corridor on Washington Street from Van Buren Blvd. to Cajalco Road have changed the composition of the community. Adjusting the boundaries will account for these changes and allow a broader spectrum of the community to participate.

9 WHEREAS, on September 7, 1999, the Board of Supervisors adopted Resolution No. 99-194,

11 Supervisors on matters including, but not limited to, public health, safety, welfare, public works and

14 WHEREAS, it is now deemed desirable and appropriate for the boundaries of the Woodcrest  
15 Municipal Advisory Council to be modified and updated; now therefore,

17 BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of Riverside,  
18 State of California, in regular session assembled on June 15, 2010, that the boundaries of the  
19 Woodcrest Municipal Advisory Council is hereby changed to include areas to the south and to exclude  
20 areas to the west and areas recently annexed by the City of Riverside.

22 BE IT FURTHER RESOLVED AND ORDERED that all provisions of previous Resolution  
23 No. 99-194 not otherwise affected by this amending resolution shall remain the same. This amending  
24 resolution is effective upon adoption by the Board of Supervisors.

**WOODCREST MUNICIPAL ADVISORY COUNCIL**

BEING ALL OF SECTIONS 23, 24, 26, 27, 34, 35, 36, AND A PORTION OF SECTION 25, OF TOWNSHIP 3 SOUTH, RANGE 5 WEST, SAN BERNARDINO MERIDIAN; ALL OF SECTION 31 AND A PORTION OF SECTIONS 19, 32, OF TOWNSHIP 3 SOUTH, RANGE 4 WEST, SAN BERNARDINO MERIDIAN; ALL OF SECTION 6 AND A PORTION OF SECTION 7, OF TOWNSHIP 4 SOUTH, RANGE 4 WEST, SAN BERNARDINO MERIDIAN; AND ALL OF SECTIONS 1, 2, 3 AND A PORTION OF SECTIONS 10, 11 AND 12, OF TOWNSHIP 4 SOUTH, RANGE 5 WEST, SAN BERNARDINO MERIDIAN DESCRIBED AS FOLLOWS:

**BEGINNING** AT THE NORTHWEST SECTION CORNER OF SAID SECTION 27, ALSO BEING A POINT ON THE BOUNDARY OF THE CITY OF RIVERSIDE;

THENCE EAST ALONG THE NORTH SECTION LINE OF SECTION 27 AND THE BOUNDARY OF THE CITY OF RIVERSIDE TO THE INTERSECTION OF SAID SECTION LINE AND THE CENTERLINE OF CORSICA AVENUE, ALSO BEING THE NORTHEAST SECTION CORNER OF SAID SECTION 27;

THENCE NORTH ALONG THE WEST SECTION LINE OF SAID SECTION 23 AND SAID CITY BOUNDARY TO THE NORTHWEST SECTION CORNER OF SAID SECTION 23;

THENCE EAST ALONG THE NORTH SECTION LINES OF SAID SECTIONS 23, 24, 19 AND SAID CITY BOUNDARY, TO THE CENTERLINE INTERSECTION OF JOHN F. KENNEDY DRIVE AND WOOD ROAD ALSO BEING THE NORTHEAST SECTION CORNER OF SAID SECTION 19;

THENCE SOUTH ALONG THE EAST SECTION LINE OF SAID SECTION 19, SAID CITY BOUNDARY, AND THE CENTERLINE OF SAID WOOD ROAD TO AN ANGLE POINT IN THE SAID BOUNDARY;

THENCE WEST ALONG SAID CITY BOUNDARY TO A POINT ON THE CENTERLINE OF PRAIRIE WAY;

THENCE NORTHERLY SAID CITY BOUNDARY ALONG THE SAID CENTERLINE OF PRAIRIE WAY TO CENTERLINE INTERSECTION OF COLT STREET AND PRAIRIE WAY;

THENCE WESTERLY ALONG THE CENTERLINE OF SAID COLT STREET AND SAID CITY BOUNDARY TO AN ANGLE POINT ON THE CITY BOUNDARY;

THENCE SOUTHERLY ALONG SAID CITY BOUNDARY TO AN ANGLE POINT THEREIN;

THENCE WESTERLY ALONG SAID CITY BOUNDARY TO THE CENTERLINE OF WINCHESTER WAY;

THENCE SOUTHERLY ALONG SAID CENTERLINE TO AN ANGLE POINT IN SAID CITY BOUNDARY;

THENCE WESTERLY ALONG SAID CITY BOUNDARY TO A POINT ON THE CENTERLINE OF DAUCHY AVENUE;

THENCE SOUTHERLY ALONG SAID CENTERLINE AND SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF VAN BUREN BOULEVARD AND DAUCHY AVENUE;

THENCE WESTERLY AND SOUTHWESTERLY ALONG THE CENTERLINE OF VAN BUREN BOULEVARD AND SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF VAN BUREN BOULEVARD AND GAMBLE AVENUE;

THENCE SOUTHERLY ALONG THE CENTERLINE OF GAMBLE AVENUE TO AN ANGLE POINT ON SAID CITY BOUNDARY;

THENCE EASTERLY ALONG SAID CITY BOUNDARY TO AN ANGLE POINT THEREIN;

THENCE NORTHERLY ALONG SAID CITY BOUNDARY TO A POINT OF INTERSECTION WITH THE WESTERLY EXTENSION OF THE CENTERLINE OF BOBBITT AVENUE;

THENCE EASTERLY ALONG SAID WESTERLY EXTENSION AND THE CENTERLINE OF BOBBITT AVENUE AND SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF CHICAGO AVENUE AND SAID BOBBITT AVENUE;

THENCE SOUTHERLY ALONG THE CENTERLINE CHICAGO AVENUE AND SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF KRAMERIA AVENUE AND CHICAGO AVENUE;

THENCE WESTERLY ALONG THE CENTERLINE OF KRAMERIA AVENUE AND SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF GAMBLE AVENUE AND KRAMERIA AVENUE;

THENCE SOUTHERLY ALONG SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF GAMBLE AVENUE AND MARIPOSA AVENUE;

THENCE EAST ALONG THE NORTH SECTION LINES OF SAID SECTIONS 36, 31 AND 32, AND CENTERLINE OF MARIPOSA AVENUE AND SAID CITY BOUNDARY TO THE CENTERLINE INTERSECTION OF BARTON STREET AND MARIPOSA AVENUE;

THENCE LEAVING SAID CITY BOUNDARY SOUTHERLY ALONG THE CENTERLINE OF BARTON STREET AND SAID WEST BOUNDARY, TO THE CENTERLINE INTERSECTION OF NANDINA AVENUE AND BARTON STREET AND THE BOUNDARY OF THE MEAD VALLEY COMMUNITY PLAN AS ADAPTED IN MAY 1996;

THENCE WESTERLY ALONG THE CENTERLINE OF NANDINA AVENUE AND SAID COMMUNITY PLAN BOUNDARY TO AN ANGLE POINT THEREIN;

THENCE SOUTHERLY ALONG SAID COMMUNITY PLAN BOUNDARY TO AN ANGLE POINT THEREIN;

THENCE WESTERLY ALONG SAID COMMUNITY PLAN BOUNDARY TO AN ANGLE POINT THEREIN;

THENCE SOUTHERLY ALONG SAID COMMUNITY PLAN BOUNDARY TO THE CENTERLINE INTERSECTION OF SPALDING AVENUE AND COLE AVENUE;

THENCE SOUTHERLY, CONTINUING ALONG THE CENTERLINE OF COLE AVENUE AND SAID COMMUNITY PLAN BOUNDARY TO THE CENTERLINE INTERSECTION OF MARKHAM STREET AND COLE AVENUE;

THENCE WESTERLY ALONG THE CENTERLINE OF MARKHAM STREET AND SAID COMMUNITY PLAN BOUNDARY TO THE CENTERLINE INTERSECTION OF WOOD ROAD AND MARKHAM STREET;

THENCE SOUTHERLY ALONG THE CENTERLINE OF WOOD ROAD AND THE SAID COMMUNITY PLAN BOUNDARY TO CENTERLINE INTERSECTION OF CAJALCO ROAD AND WOOD ROAD;

THENCE WESTERLY ALONG THE CENTERLINE OF CAJALCO ROAD TO THE INTERSECTION OF WEST SECTION LINE OF SAID SECTION 10 AND THE CENTERLINE OF CAJALCO ROAD;

THENCE NORTH ALONG THE WEST SECTION LINES OF SECTIONS 10 AND 3 TO THE NORTHWEST SECTION CORNER OF SAID SECTION 3;

THENCE WEST ALONG THE SOUTH SECTION LINE OF SECTION 34, TO THE SOUTHWEST SECTION CORNER OF SAID SECTION 34;

THENCE NORTH ALONG THE WEST SECTION LINES OF SAID SECTIONS 34 AND 27 TO SAID CITY BOUNDARY AND THE **POINT OF BEGINNING**.
